The Taiwan Chapter, along with the Chinese Arbitration Association (Taipei), ICCYAAF, Chen & Chang, Attorneys-at-Law, the Taiwan Bar Association Mediation and ADR Committee, and the Taipei Bar Association Cross-Border Transaction and Dispute Resolution Committee were honored to invite Dr. David Fong, Chair of the CI Arb EAB, to give a speech on the topic of “Lessons from Successful Challenges to Arbitral Awards in Hong Kong” on 22 July 2022.

More than one hundred participants joined the seminar online or in-person. During the special “Meeting with the Chair” session, Dr. Fong addressed many of the attendee’s questions regarding the CI Arb.

The event was hosted by Dr. Helena Chen (Convenor of the CI Arb Taiwan Chapter, Chair of the Taiwan Bar Association Mediation and ADR Committee). The opening speech was delivered by Prof Ful-Dien Li (Chair of the Chinese Arbitration Association, Taipei) and Ms Monica Wang (Secretary-General of the CI Arb Taiwan Chapter, Chair of the Taipei Bar Association Cross-Border Transaction and Dispute Resolution Committee). The speakers also welcomed Dr. Fong for coming to Taipei for delivering this interesting seminar.

Dr. Fong’s speech can be divided into four parts. The first part introduced the Hong Kong Arbitration Ordinance and its background; the second part focused on Article 34(2) of the UNCITRAL Model Law on international commercial arbitration

## CIArb Taiwan YMG - Handover of Chairmanship and Knowledge Sharing Session on “Profile-Building”

The CIArb Taiwan YMG was pleased to welcome its new Chair and Secretary-General on 13 August 2022. A knowledge sharing session on the topic “How to Build Your Professional Profile” was also held on the same occasion.

The chairmanship-handover ceremony and the knowledge sharing session were moderated by the founding Chair of Taiwan YMG, Ms Alison Chang. Ms Chang first congratulated the outstanding achievements of the immediate past Chair, Ms Felice Fu-An Lu and the Secretary-General, Ms Szu-Yu Chen. In the speech by the immediate past Chair, Ms Lu recapped the growth of Taiwan YMG during the term of office and shared her reflections along the journey with Taiwan YMG members. This is followed by a speech from the new Taiwan YMG Chair, Ms Pei-Jung Li on the vision of the Taiwan YMG in the new term. As explained by Ms Li, the Taiwan YMG serves as a platform to accommodate the needs of young members from diverse backgrounds. It also helps the young members to gain more exposure to new opportunities in the wider region. To embark on this new journey, Ms Li delightfully welcomed the new Secretary-General, Mr Chia-Hsin Wu.

Following the ceremony, Ms Felice Fu-An Lu and Ms Alice Fu-Yi Lu delivered the first topic of the knowledge sharing session on “How to Plan Your Study Abroad Experience and What is the Perfect Timing?” The speakers shared their experiences in studying abroad and provided a comparison in the costs, opportunities and the challenges between different countries. The speakers also shared the important aspects that should be taken into consideration when deciding the best time for studying abroad, as well as the advantages and disadvantages in getting on board the journey early or later.

was covered by Ms Pei-Jung Li and Mr Yu-Teng Lin. In the beginning of their session, Ms Li and Mr Lin shared their experience on the essential elements for CVs for legal professionals, from both the applicant and reviewer perspectives. The speakers further highlighted the important features of CVs for academic purposes and work applications, and provided some useful tips for enhancement. As for the last topic, the speakers Ms Szu-Yu Chen and Mr Yi-Hsun Lin held a discussion on “Legal Internship Experience-Sharing”. The speakers generously shared their experiences at the time when they were working as legal interns in two leading law firms in Taiwan, and compared the routes of legal internship in both law firms and legal departments in corporate environment.

The event was joined remotely and in person by approximately 30 attendees, who are mostly law students and fresh graduates. In the Q&A Session, the participants raised questions on career development opportunities and how they can best prepare themselves before embarking on their career in dispute resolution. The event was concluded by the Taiwan Chapter Convenor, Dr. Helena Chen.


The Branch currently has 3,030 members in the region. Find out the composition of the Branch membership in the diagrams below.

### Distribution by Membership Grade


(excluding the Retired Members and Students)



### Distribution by Gender of Members




### Distribution by Region
