## **Mock Arbitration by EAB Philippine Chapter**

CIArb EAB supported this year's Regional Arbitral Institutes Forum ("RAIF") held in Cebu, Philippines from 21-22 June 2013 by coproducing the event's day-long mock arbitration based on the rules of arbitration of the International Chamber of Commerce ("ICC") with the Philippine Institute of Arbitrators. Conducted on 21 June 2013 at the auditorium of the University of San Jose Recoletos, the affair provided a unique opportunity for RAIF participants to witness how proceedings in international commercial arbitrations are conducted. Course Co-Directors for the event were Robin Peard of Mayer Brown JSM and Teodoro Kalaw IV of Kalaw Sy Vida Selva & Campos, who prepared the case study using material previously adopted by Louise Barrington and based on a fact situation created by Ben J. Sheppard Jr. of the University of Houston Law Centre. Mary Thomson served as EAB Regional Committee liaison for the event.

Khong Cheng-Yee, ICC's Director and Counsel in charge of the ICC

International Court of Arbitration Secretariat – Asia Office, explained the proceedings together with Course Co-Director Kalaw, who served as the mock arbitration's narrator, while Donemark J. L. Calimon of Quisumbing Torres (a member firm of Baker & McKenzie International) explained the proceedings from the Philippine law perspective. The arbitral tribunal was chaired by Course Co-Director Robin Peard, with Celeste Ang of Baker & McKenzie, Wong & Leow (Singapore) and Mario E. Valderrama as members. Ruth Stackpool-Moore, Managing Counsel of the Hong Kong International Arbitration Centre, together with Mr. Abraham M. Acosta of Quisumbing Torres and the University of San Jose Recoletos, acted as counsel for the claimant. Messrs. Ricardo Ma. P. G. Ongkiko and Romeo D.Lumagui, Jr., both from SyCip Salazar Hernandez & Gatmaitan, acted as counsels for the respondent. Eduardo R. Ceniza of ERCeniza & Associates served as interim measures judge.

The event marks the first time an international mock arbitration was conducted in the country, and has directly resulted in a request by the Office of Alternative Dispute Resolution of the Department of Justice of the Republic of the Philippines for a repeat performance when the country celebrates its ADR Week on 16 to 19 December 2013.

## CIArb 2013 International Arbitration Conference **Arbitration: Tapping Asia's Growth**

Penang Malaysia 22-24 August 2013

The CIArb 2013 International Arbitration Conference was successfully held in Penang Malaysia from 22 to 24 August 2013 with approximately 300 delegates coming from different countries of the world.

The conference was opened on 22 August 2013 by The Right Honourable Tun Arifin Zakaria (Chief Justice of Malaysia), and then followed by keynote address by The Right Honourable Mr. Sundaresh Menon (Chief Justice of Singapore) and Mr Vinayak Pradhan (President of the CIArb). Full-day conference was held on both 23 and 24 August 2013 with distinguished speakers from various countries of Asia as well as United Kingdom, Australia and Switzerland, which included Mr Anthony Abraham (CIArb Director General), Mr John Wright and Mr Dong Jones. The EAB Chair, Mr Man Sing Yeung, was the moderator for the session entitled tapping into growth in specialized sectors in Asia. The trustee of East Asia, Mr Colin Wall, participated in the interactive session entitled current & hot topics in international arbitration practice. Other speakers from the EAB included Mr Timothy Hill, Ms Teresa Cheng SC and Mr Philip Yang.

The conference was very well organized and all the participants enjoyed their time in Penang.

## Evening Talk by Mr. Rajiv Dutta, Senior Advocate, on "Growing Importance of India as a World Economic Power and Myths Surrounding Arbitration Practice in India"

Hong Kong 2 August 2013

In the evening of 2 August 2013, Mr. Rajiv Dutta, who is a well-known figure in the India legal community, gave us a talk entitled "Growing Importance of India as a World Economic Power and Myths Surrounding Arbitration Practice in India".

Following the initiation of economic reforms in 1991, there had been a growing of foreign investment in India which thus led to issues of disputes. Mr. Dutta gave us an overview of the problems arising from the old Arbitration Act 1940 particularly judicial intervention. He also discussed the provisions under the new Arbitration and Conciliation Act 1996, which was an adoption of the UNCITRAL Model Law, as well as the several hurdles in its implementation and the subsequent recommendations of the Law Commission in India. He considered that arbitration in India is still evolving and in this regard he made several suggestions, which focused on the mindset of the members of the Bar, development of full time arbitrators, practice in drafting the arbitration agreements adopted by the government departments, etc. and the emphasis given to institutional arbitration. He concluded that India has been moving in the right direction albeit it remains behind the rest of the world.

## Winnie Whittaker Memorial Lecture – Talk on "Revitalization of Salt-pans at the Island of Yim Tin Tsai Sai Kung" by Anna Kwong

Hong Kong 21 June 2013

The 8th Annual Winnie Whittaker Memorial Lecture was held on 21 June 2013 at the HKIAC. The speaker was Ms Anna Kwong, the immediate past president of the Hong Kong Institute of Architect.

Before the beginning of the talk, Ms Kwong and our members played a moment of silence as tribute to Winnie. Ms Kwong then started the talk by giving an account of her encounter with Winnie when they both worked at the Housing Department of the then Hong Kong Government and the development of their friendship. Ms Kwong then introduced our members to the St Joseph Chapel Conversation Project at Yim Yin Tsai, Sai Kung. St Joseph Chapel was awarded the UNESCO Asia-Pacific Heritage Awards in 2005. She first looked

at the history of the Chapel, clan history of the Yim Yin Tsai village, and how the Roman Catholic Diocese of Hong Kong conserved the Chapel under the theme of "Add nothing and taking nothing."

Ms Kwong then turned to the second part of her talk, the saltpan revitalization project. She gave an account of the history of saltpan in Yim Tin Tsai village in the 19th century, its decline, and how the salt pan revitalization project begins in 2013. Method of productions in saltpan at Tainan was discussed. The contract type with dispute resolution procedure had also been highlighted.

The talk was well attended and member found the talk both informative and interesting.

# "Nuts and Bolts" of Arbitration Lecture No 9: "Costs, Offers to Settle and Payments-in" by Glenn Haley

On 18 June 2013, Mr. Glenn Haley gave Lecture No. 9 of the "Nuts and Bolts" series on "Costs, Offers to Settle and Payments-in" at the Hong Kong International Arbitration Centre. The lecture was real time transmitted to Philippine chapter and Taiwan chapter via Webex, and such service was sponsored by Merrill Corporation.

The lecture covered various important areas including what costs are, the power and jurisdiction, types of costs orders, who assesses the costs, the assessment process, assessment of the Arbitrator's fees and expenses, offers to settle and payments into court. Mr. Haley explained these areas by reference to the new Arbitration Ordinance as well as compared with the relevant provisions in the old Arbitration Ordinance.

## YMG Evening Talk on "What assistance will a Tribunal be seeking from counsel, experts and factual witnesses in an arbitration?" by Professor A Reyes

### Hong Kong 7 June 2013

On 7 June 2013, following the CIArb (EAB) YMG Annual General Meeting, YMG members had the honour to attend an evening talk by Professor Aselmo Reyes on "What assistance will a Tribunal be seeking from counsel, experts and factual witnesses in an arbitration?". An ex-judge of the Court of First Instance, Professor Reyes is a commercial arbitrator, advocate in arbitrations, mediator, professor of legal practice and author.

Professor Reyes commenced the talk by briefly exploring what one might expect of the tribunal. Drawing from his own experience, Professor Reyes compared the roles of a judge and that of an arbitrator. Moving onto the main subject of the talk, Professor Reyes

emphasised the importance for all parties to an arbitration to be issue-focused and realistic. The two can be considered one – let issues drive arbitrations realistically. With this running theme in mind, Professor Reyes went on to discuss with the audience how best advocates, experts, factual witnesses and lay-clients may conduct in arbitrations. For example, advocates can assist the tribunal by being well prepared and breaking down the case into a few key issues, which then frame discovery and witness and expert statements required. Parties are encouraged to suggest a fair timetable and an orderly protocol early on. Witnesses, both factual and expert, should only be involved if necessary. The talk, which attracted a full house, was followed by a lively Q&A session.
